Explanation of Responses:

- At the Effective Time (as defined in the Agreement and Plan of Merger, dated June 28, 2018 (as amended, the "Merger Agreement"), by and among the Company, SYNEX Corporation, Delta Merger Sub I, Inc. and Concentrix CVG Corporation), these phantom shares held under the Company's Deferred Compensation Plan for Non-Employee Directors were converted into \$247,013.11 in cash based on the closing price of Convergys common stock on October 4, 2018.
- At the Effective Time, these time-based restricted stock units and deferred stock units were converted into the right to receive \$820,571.16 in cash, which amount will vest and be paid in accordance with the Merger Agreement and the applicable award agreements.
- At the Effective Time, these shares were cancelled pursuant to the Merger Agreement in exchange for the right to receive \$511,370.50 in cash and 4,874.42 shares of SYNEX Corporation common stock having a market value of \$89.14 per share, based on the closing price of SYNEX common stock on October 5, 2018.
